*** The Affiliated Law Colleges shall compulsorily comply with the above admission calendar of events for the Academic year 2024-25.

**** The colleges are required to remit the admission fees of the students to the University on or before 17.09.2024 mandatorily. If the colleges fails to remit the fees within the stipulated date then a fine of Rs. 500/- per day will be imposed till the actual remittance.

Note :

- 1) All other conditions stipulated in the Admission Notification No. KSLU/Reg/Acad-II/Admn-Notif/ 2024-25/338 dated: 24.05.2024 and KSLU/Reg/Acad-II/Admn-Notif/2024-25/ 681 dated: 28.06.2024 remains same.
- 2) Students have to apply for eligibility certificate through Seva Sindhu portal up to 08.08.2024. (it is applicable only to the affiliated law colleges which have BCI permission recently and the affiliated law colleges where the seats are still remaining vacant)
- 3) As regarding those affiliated law colleges which have already finalised the first list and selected the candidates and notified the same, such notification of selected candidates remains valid. Such colleges need not change the notified list in view of the revised notification.
